I. MISCELLANEOUS SPECIFICATIONS

- Specifications are not intended to eliminate any reputable manufacturer, brand or bidder. Reference to
 manufacturers, brand names, suppliers catalog numbers, etc., is intended to set quality standards and does NOT
 exclude bids from others as long as quality standards are met. Pictures, descriptions and specifications shall
 accompany all bids.
- 2. If a bid differs in any way from the bid specifications, the bidder must list the differences on the bid proposal form telling exactly where and how the bid deviates from said specifications. If no exceptions are listed on the bid, it will be presumed the bidder proposes to meet the specifications in every respect; and if awarded the contract, performance on this basis will be required.
- 3. It is the bidder's responsibility to comply with all local, state and federal laws as they apply to this bid.

If the bid amount is \$10,000.00 or more a certified check or bid bond, payable to the Opelika city board of Education, in the amount not less than five percent of the amount of the bid (1st year's contract total) but in no event more than \$10,000, must accompany the bidders proposal. Said bond will remain in effect until the contract is completed.

- 16. **Contract to begin on July 1, 2021** and end on June 30, 2022. Contract will be awarded within 10 days of BOE awarding bid. Contract may be extended on agreement by Opelika City Schools and the vendor for an additional two (2) 1 year contracts (July 1, 2022-June 30, 2023 and July 1, 2023-June 30, 2024, respectively) with an escalation increase in price permitted of 3% for the second (2nd) year and 2% for the third (3rd) year.

III. Service Specifications:

- A. Weed trimming and edging of all concrete/asphalt surfaces on school campus. In addition, spray treatment (weed control) should be applied for routine maintenance.
- B. Mowing of all grass areas on outside perimeter of each campus.
- C. Blowing of all mowing, edging and weed trimming debris.
- D. Shrub pruning three (3) times per year March, July, and November.
- E. Weed trimming around all trees, shrubs, and stationary objects.
